
Notification

It is notified for information of all the employees of DA/DAO cadre under the administrative control of the Pr. Accountant General (A&E) Odisha, that the recognition under CCS (RSA) Rules of the Odisha Divisional Accounts Officers & Divisional Accountants Association expired on 15.10.2013. The fact of such expiry and time schedule for seeking renewal of recognition was notified vide this office order No.03 dated 10.04.2013. As the Association could not comply with the requirements of prescribed documentation and has submitted undertaking vide its letter No.07 dated 16.03.2017 to comply with all the requirements with effect from the year 2017-2018, the competent authority has ordered to call for fresh application for recognition.

In order to consider the grant of recognition for a period of five years after verification of their membership under the check-off system as per the extant instructions, the following time schedule is drawn for processing fresh applications of associations seeking recognition under CCS (RSA) Rules 1993.

(c)	Writing to the associations who have applied for recognition, for resubmitting the amended constitution etc. as per preliminary observations, if any, made by the Head of Office.	04.09.2017

(d)	Notifying for information of the employees the names of the associations, which fulfil all the conditions of recognition laid down in Hdqrs letter No.295-NGE(JCM)/40-94-I dated 17.04.1995 and calling for written declaration for deduction of membership subscription on a monthly basis, from the employees, so that the recovery through pay rolls in respect of all the employees may start from the same month/next month.	04.10.2017


