The Divisional Accountant Grade Examination (DAGE) will be held in the month of September, 2018 as per the programme appended hereto in the office of the Pr. Accountant General (A&E), Odisha, Puri.

Divisional Accountants (Probationer) who are completing one year of training as on 23.09.2018 are directed to send their application in the enclosed proforma to WM Section by 24.08.2018 positively. Divisional Accountants (Probationer) who will be completing at least 10 months of service as on 23.09.2018 and willing to appear in the September 2018 Examination may also apply along with a separate application for condonation. They will be permitted to appear for the examination subject to condonation of the deficiency in services by the Competent Authority. DAs(P), who have already completed 2 years of probation but have not cleared the DAGE, may apply separately for extension of their probation period. Their appearance in the DAGE would be subject to extension of probation period by the competent authority.

The syllabus of the examination is given in Annexure-II to the Chapter-VII of the C.A.G.'s Manual of standing Orders (Admn.)-Vol-I.

Candidates are allowed to use their own simple calculators for performing basic arithmetical functions like addition, subtraction, multiplication and division as well as calculation of percentage while appearing in the examination.

Besides, candidates will be required to pass language test in Odiya as prescribed. Candidates who have passed H.S.C. examination or equivalent/Higher examination with Odiya as one of the subjects are exempted from appearing for the language test in Odiya provided they furnish documentary evidence to that effect.
