Candidates are allowed to use their own simple calculators for performing basic arithmetical functions like addition, substraction, multiplication and division as well as calculation of percentage while appearing in the examination. However, no other electronic instruments including Mobile Phones are allowed into the Examination Hall.

Candidates resorting to unfair means/malpractice/copying will be debarred from the examination and liable for disciplinary action.

The candidates are allowed to write all the papers either in English/Hindi as per the options given by them.

The Candidates who have no examination in any particular day, are directed to remain present in the Office of the Principal Accountant General (A&E) Odisha, Puri Branch, Puri.
