**OFFICE ORDER**

In pursuance of Headquarters' Office Circular No. 21-Staff Wing/2019 circulated vide letter No.571-Staff (Appt.)/PC Cell/02-2017, dt.14.05.2019, the Accountant General has been pleased to grant Non-Functional Upgradation (NFU) to the Divisional Accounts Officers Grade-I, whose names are mentioned in 'Annexure-A' enclosed with this order, in Pay Level-9 of the Pay Matrix on completion of 4 years regular service in the Pay-Level-8 with effect from the dates mentioned against their names.
