Sub: - Calling for applications for Departmental Examination for Auditors from Auditors, Graduate Clerks (SC/ST category) and Graduate MTS (all categories) proposed to be held in August 2015.

The next **Departmental Examination** for directly recruited Auditors, Auditors promoted from clerk cadre, Graduate Clerks (SC/ST category) and Graduate MTS (all categories) will be held in **August 2015**.

All directly recruited auditors completing one year of continuous service, Auditors promoted from clerk cadre on seniority basis on completion of 90 days of continuous service as Auditor, Graduate Multi-Tasking staff or Graduate Clerks in audit offices with three years of continuous service are also eligible to appear in this departmental examination for auditors for being considered for promotion against the promotion quota.

As per para 9.4.4 Revised Chapter IX of C&AG MSO (Admn.), Vol – 1 dated 20.02.2014, **Principal Accountants General/Accountants General/Principal Directors of Audit** may at their discretion, condone deficiencies in the prescribed service of one year in respect of directly recruited Auditors and in prescribed service of three years in respect of clerks **up to a limit not exceeding two months**. Hence, directly recruited Auditors and Graduate Clerks/Graduate MTS officials having deficiency in the prescribed services up to a limit **not exceeding two months** as on the **crucial date i.e.01.08.2015** may apply separately to the Accountant General (G&SSA) for condonation of such deficiency in qualifying service. Clerks promoted to Auditor cadre may take examination immediately after their promotion. However, they may not appear the examination, if it is held within 90 days of their promotion. They may instead appear their first examination immediately thereafter. The reverted clerks will have three more chances to clear this examination within two years of of the reversion.

Failure to appear for the above examination or absent from the examination for whatever reasons will also be taken as chance availed of as per instructions contained in Para 9.4.2. of Chapter IX of MSO (Admn.), Vol – I (Revised 3rd Edition).

Applications in the prescribed Proforma (enclosed) may be submitted through proper channel so as to reach the Examination (G&SSA) Section on or before **07.07.2015**. Application Forms can also be accessed from our website **http:ag Odisha.gov.in./** &intranet site **192.168.0.253**.
