VACANCY NOTIFICATION

Applications are invited from the retired Sr. Audit Officers/ Audit Officers and Asst. Audit Officers not beyond the age of 64 years to work as Consultants in the post of Asst. Audit Officer (three numbers) in the Office of the Accountant General & Social Sector Audit), Odisha on short term contract basis initially for a period of 11 months. However, the period of such contract can be further extended upto a maximum of three terms (11 months each) depending upon their performance and requirement of the office. During the period of contract, a contractual payment of ₹ 43,125/- p.m. in case of retired Sr.AOs/AOs and ₹34,500/- p.m. in case of retired AAOs would be payable. Retired Sr.AOs/AOs appointed on short term contract in the vacancies of AAO cadre would be payable ₹34,500/- p.m. Further, the following terms and conditions are applicable in respect of the retired officers appointed on short term contract basis:

- 1. Retired officers/CAs/CMAs hired on short term contract basis in field offices of IA&AD are eligible 10 days leave (08 CL & 02 RH) in a calender year on pro-rata basis and shall not draw any remuneration in case of his/her absence beyond 10 days (08 CL & 02 RH) in a year (Calculated on a pro-rata bases). Further, un-availed CL/RH cannot be carried forward to next year.
- 2. If the retired officers/CAs/CMAs are required to attend the office on Saturday/Sunday and other holidays in exisgencies of work, they shall not be paid any additional remuneration.
- 3. To enable timely, reasonable and regular enhancement of remuneration, it has also decided that 50% of each increase in Dearness Allowance may be henceforth be passed to the retired officials hired on short term contract basis.
- 4. No House Rent Allowance, residential accommodation and Transport Allowance shall be paid to the contractual retired officers.
- 5. Refired contractual officers shall not be deputed on field audit duties/inspection. In case of exigencies, if the situation so demands, they may be deputed on field duty and TA/DA shall be paid as per existing rules in accordance with the Grade Pay of the post against which they have been hired. However, in such cases, they shall not issue any audit/inspection memo which will be issued by a regular officer only.
- 6. Retired contractual officers are not authorized to either write or review the APARs of regular staff. In such cases, the officer just above the regular employee in the hierarchy will act as the Reporting Officer/Reviewing officer.
- 7. All rules and orders in existence or to be issued from time to time regarding attendance, duties and official disciplines etc. would automatically be applicable to all the retired contractual officers.
- 8. Statutory deductions levied by the Union/State Government shall be made from the contractual payment as per rules.
- 9. The contractual period may be terminated prematurely at the sole discretion of the Accountant General (General & Social Sector Audit), Odisha.

The willing retired officers may submit their applications along with their bio-data to the Sr. Audit Officer/Admn (G&SSA) on or before 06.09.2019.
