Eligibility Criteria for appearing in Revenue Audit Examination

In terms of revised para 9.3.1.1 of MSO Admn(Vol.-I) eligibility criteria in respect of Sr.AO /AAOs for appearing in Revenue Audit Examination are as under.

- a. Sr.AOs after having one year of continuous service in the Revenue Audit Branch as AAO/Sr.AO or after having prescribed training in the Revenue Audit
- b. Departmental officials who are promoted as AAO are eligible for Revenue Audit Examination after completion of one year continuous service in Revenue Audit branch ; or have the prescribed training in Revenue Audit after completion of one year of regular service as AAO.
- c. The confirmed Directly Recruited AAOs are eligible to appear Revenue Audit Examination after completion of one year continuous service in Revenue Audit branch as a regular AAO; or have the prescribed training in Revenue Audit after completion of one year of regular service after confirmation as AAO.

Training will be arranged for the fresh RAE candidates during August.2020. Hence applications as per the enclosed proforma are invited from the eligible fresh candidates so as to reach the Trg.& Exam. Section (Audit-I), on or before 10th July 2020

Applications received in the Examination Section (Audit-I) beyond the stipulated date will not be entertained under any circumstances. The candidates will have to register their candidature online for the above exam. The date of such registration will be intimated in due course.
