## Circular

As per the provisions contained in clause II of Rule 18(1) of CCS (Conduct) Rules 1964 real with G.I.D No 22 thereunder, every Government servant belonging to any service or holding any post is required to submit an annual property return statement inrespect of every calendar year by 31st January of the next year giving full particulars regarding the immovable property inherited by him/her or owned or acquired by him or held by him/her on lease or mortgage either in his/her name or in the name of any member of his/her family or in the name of any other person.

Since the Annual Property Return statement for the year 2015 has not been submitted by 52 nos of DAOs/DAs (list attached), they are directed to submit their Annual Property Return statement for the year 2015 by 31.07.2016 positively. Failure to adhere to the above time schedule would be viewed seriously and action as deemed fit will be initiated against them.
